

## **Silvia's Gymnastics. Privacy Statement**

At Silvia's Gymnastics. we understand that privacy is an important issue for visitors to our web site ([www.silivasgymnastics.com](http://www.silivasgymnastics.com)). The following information is designed to help visitors understand what information we gather from our site, and how we handle the information once we gather it.

### **Information Collection and Use**

In general, there are two types of information collected over the Internet: personally identifiable information and anonymous information. Personally identifiable information refers to that information that is unique to an individual, such as a name, address, social security number, or e-mail address. Anonymous information is that information typically collected in aggregate for statistical purposes, with no reference to personally identifiable information pertaining to the visitors of the site. One of the most important uses of this information is to assist with claim administration, including payment status.

All personal information that you provide on this site will be kept confidential. Silvia's Gymnastics. will not sell, share, or rent this information to others in ways different from what is disclosed in this statement.

### **Security**

Where appropriate, we employ firewalls, encryption technology, use authentication systems (e.g., passwords and personal identification numbers) and access control mechanisms to control access to systems and data.

If you do obtain a password or personal identification number from us, you should not share that information with others. If Silvia's Gymnastics. becomes aware that a visitor to a Silvia's Gymnastics Web site is determined to have logged in as another user in order to gain access to personal and confidential information, this would be considered a breach of security. Silvia's Gymnastics. reserves the right to terminate access for a user's login if a breach has been determined.

### **Cookies**

A cookie is a piece of data stored on the user's hard drive containing information about the user. Usage of a cookie is in no way linked to any personally identifiable information while on our site. Cookies can also enable us to track and target the interests of our users to enhance the experience on our site.

### **Log Files**

We use IP addresses to analyze trends, administer the site, track user's movement, and gather broad demographic information for aggregate use. IP addresses are not linked to personally identifiable information.

## **Sharing**

We may share aggregate demographic information with our partners. This is not linked to any personal information that can identify any individual person. Partners are not allowed to use personally identifiable information except for the purpose of providing the services requested of them.

## **Surveys**

From time-to-time our site may request information from users via surveys. Participation in these surveys is completely voluntary and the user therefore has a choice whether or not to disclose this information. Information requested may include contact information (such as name and address), and demographic information (such as zip code, age level). Each survey offered will contain a statement disclosing the purpose and use of the survey information. Please read this disclosure before proceeding with any survey.

## **Notification of Changes**
